Navigation data and cookies

The computer systems and software procedures used to operate the <https://www.agriturismoiltripesce.com> website acquire, during their normal operation, some data whose transmission is implicit in the use of Internet communication protocols. No personal data is acquired by the site unless knowingly provided by the user. In fact, no software is used to transmit information of a personal nature, although software (cookies) are used to monitor, in an aggregate way and not able to trace the visitor's identity, the browsing habits of our customers in order to improve the service offered and make navigation on the site safer and more efficient.

What is a cookie and what is it used for?

A cookie is a small file that is sent to the browser and saved on your device when you visit a website like ours. Cookies allow the site to function efficiently and improve its performance. They can provide the site owner with various types of information for statistical or advertising purposes, mainly used to personalize your browsing experience by remembering your preferences. For example, they can remember your preferred language and currency to set them on the next visit, avoiding you to indicate them again.

WHICH COOKIES DO WE USE AND FOR WHAT PURPOSES?

Our site uses different types of cookies and related technologies, each of which has a specific function. Below is the list of cookies used by our site.

Navigation cookies

They are created at the first access; allow the site to work properly and faster and allow you to view the contents on your device by recognizing the language and country from which you have chosen to connect. If you are a registered user, they will allow you to be recognized and to access the services offered in the dedicated areas. Navigation cookies are technical cookies and are necessary for the site to function. They cannot therefore be deactivated

Functional cookies

If you have added items to your cart and closed the session without completing the purchase and without deleting them, you can continue shopping the next time you access the site - within a limited period - by finding the selected items. Functional cookies are not essential to the functioning of the site, but they improve the quality and browsing experience.

Analytical cookies

These cookies are used to process statistical analyzes on how users navigate our site. The site may use some third party services which, in a completely independent way, install their own cookies.

Cookies are generally characterized as text files containing small amounts of information that are downloaded to the user's device, only if this is enabled, who visits the sites of <https://www.agriturismoiltripesce.com>.
